

The Executive Editor of the Press Democrat and the Principal of Cardinal Newman High School are both Ambassadorial Scholars. Their paths first crossed a generation ago when Cathy—a USC graduate—and Graham—a graduate of Santa Clara—were selected to study in the United Kingdom as part of the Rotary Foundation's oldest and best-known program. One of the world's largest privately-funded international scholarships was founded in 1947 to further international understanding and friendly relations among people of different countries. Academic year scholarships are awarded to undergraduate and graduate students, and business professionals pursuing vocational studies.

They serve as goodwill ambassadors abroad and share the experiences that led to a greater understanding of their host country when they return home.

Catherine Barnett & Graham Rutherford will compare the impacts of their experiences on their lives. We can ask them questions and bask in the glow of the meaningful, long-term contributions to society that come from our support of Rotary.

## CORPORATE MEMBERSHIPS APPROVED

At today's meeting, the membership voted unanimously to apply as part of Rotary International's three-year pilot program that would allow individual Rotary Clubs to extend memberships to a company or corporation. Traditionally membership has been limited only to individuals, but as of July 1, 2011, a business entity may become a member of a Rotary Club and may designate up to four company representatives to attend club meetings, participate in all club activities, etc. The member organization will pay membership dues to Rotary International, but all other club fees, meal costs, etc. may be set by individual Rotary clubs. The pilot program will allow participating Rotary Clubs to reach out to major businesses in their community whose employees may not have the time during the business day to attend meetings on a regular basis. A corporate designee may convert from their corporate status to an individual membership in the club. More information is available at the RI website under "Pilot Programs".

In his capacity as Co-Chair of the Joint Charitable Projects Committee, **Acting President Will** presented this Rotary year's grant awards to this local transition program for homeless women and children. ## THE PROGRAM

After more than a decade of dreams, intense dedication, and hard work, The Children's Village of Sonoma County has become a stable family home in a multi-generational,

enriched environment that nurtures foster care children and their siblings in the five years since it opened. Located on two acres in southeast Santa Rosa, the Village has eight family homes, the Village Center, a playground, ball court, and gardens. "Village Parents" are responsible for their care and for meeting individual and family needs. "Village Grandparents" live on-site and provide a unique intergenerational component, sharing hobbies, school, and

sporting events, listening and sharing with the children.

The guest speaker was development director Diane Estrin, who compared the Village's environment with the typical world of displaced, unwanted, children who are severely damaged by life's troubles, unwanted by society, their parents, and overburdened semi-solutions to their problems. With more than 600 children in foster care just in Sonoma County, most with little opportunity for adoption, the Village gives two or three dozen children some hope of a stable and happy childhood and a productive adulthood.
