

Forty years ago, after serving his time in Viet Nam, Rookie Cop Larry Frederick earned the Oakland Police Department's Medal of Merit attempting to save the life of a drowning victim. It took nine major surgeries and more than 100 pints of whole blood to save his life and repair his massive injuries. His law enforcement career was over, but after extensive rehabilitation and physical therapy, vocational rehabilitation brought him to Sonoma State, where he majored in management and marketing. PROGRAM

Today's program featured Jill Kinney, co owner with her husband John of Club One, a premier fitness club. Started in 1991, Club One now has over 140 clubs in the U. S. Jill shared the vision she has that for her club to become a vital wellness and social center that serves each the community in a variety of ways. Club One strives to work in partnership with each community it enters to provide what amounts to a “privately owned community center”. In addition to the usual training equipment and swimming pools, Club One includes meeting rooms, separate children's areas, spa facilities and services, a variety of wellness and fitness classes. A large area for social gathering is also typical of a Club One facility.

Two years ago, Club One opened a 40,000 sq. ft. site in Petaluma that features an outdoor Olympic sized swimming pool, water slides, meeting rooms, weight training machines, ellipticals, and all other manner of fitness equipment. There are rooms for a variety of dance, work out and spin classes. A large staff of personal trainers are available to work with members to develop an appropriate program. There is also an onsite café operated by owners of local Petaluma favorite Beyond the Glory.

Ms. Kinney cited a few facts about the wellness/fitness industry and Club One in particular:

- 24 percent of the population is a likely buyer of a health club membership
- The 50 year-old-plus market is the fastest growing demographic sector
- Community health clubs—40,000 to 60,000 sq. ft. in size—operate on a 20 to 30 year business cycle.
- The Petaluma fitness center has generated \$1.6 million in new taxes, created 194 jobs and a total \$3.48 million in revenue.
- The Petaluma site offers rentable conference rooms and non-members can pay a flat fee to take individual classes.

Ms. Kinney reasons that in many cases a privately-owned, well-planned community center can serve the community more effectively and at less cost to a city than a publicly-

owned site while at the same time generating jobs and tax revenue for the community. A Club One is in the planning stages in Santa Rosa's Railroad Square area that could include a two-story club with senior housing in an additional three floors above the workout space. Stay tuned!
