

Reaching Our Goals

Assets of the Foundation reached \$1,415,501.00 for 2016, an increase of nearly \$42,000 from the prior year. This increase was made possible because of a combination of \$35,030.00 in contributions plus investment returns of \$69.222.00. This gave us the ability to provide \$46,800 in scholarships and community
