The Foundation has received a contribution of \$500.00 from an unrelated corportion which at the time of receipt exceeded ten percent of the Foundation's assets. The Foundation does not expect to receive more than ten percent of its assets from one person; however, while the Foundation's endowment fund is in its formative stage it is possible that some contributions received may exceed ten percent of assets.

Question 7e and f

Statement of purpose and activities:

Present and proposed activities consist of the formation of an endowment fund from contributions received primarily from members of the Rotary Club of Santa Rosa and from members of the public through memorial contributions on behalf of deceased Rotary Club members. It is expected that, over time, major gifts will be received by bequest from estates and trusts of Rotary Club members. The Foundation will accumulate contributions received and will then distribute only net income from the endowment fund to selected qualified Section 501(c)(3) organizations located or operating in the general area of Santa Rosa, CA. Specific recipient organizations have not yet been identified, but it is likely that they are of the type that would qualify for funding by the United Way. The foundation trustees will decide which qualified organizations will be recipients. No fund-raising events or business operations are planned in connection with functioning of this foundation.

No committees or professional fund raisers are contemplated. The only fund raising activity thus far has been to make announcements at Rotary Club meetings and through the Club's bulletin.
