1. Approval of minutes - MSA Olson/Chase

PRESIDENT'S REPORT: MCMILLAN

1. McMillan reminded board that all members must complete a Conflict of Interest statement. It will be sent to them shortly.

INVESTMENT REVIEW: STEVE REUTER, financial advisor

- 1. Reuter noted that we currently have \$250,000+ in our account. He discussed what to do with it. Interest on cash accounts is .0 6% currently, with no improvement expected any time soon. He considers the best choice in fixed income investments currently is preferred stock. However, these investments are rated DD-, below investment grade. The Foundation's investment policy does not permit the purchase of below investment grade assets.
- 2. He recommended that we change our investment policy to include DD- rating as investment grade and that we invest our excess cash divided equally among 3-4 financial institution preferreds paying a 4-5% return. MSA Hatcher/Giampaoli to change our investment policy to include DD- rating in investment grade. MSA Hatcher/Anderson to invested \$200,000 divided equally among 3-4 preferreds to be recommended by Reuter.

 - a. Hardcastle reviewed financial statements for 6/30/20 (distributed in advance). Total assets were \$1,929,154. Net income for the year to date was \$170,930.
